2012 Conference Overview

This conference will focus on policy and its far reaching impact on the overall health of Oklahomans. Presentations from nationally-recognized experts will help facilitate discussions on innovative, broad-based approaches to health policy change. The complex ways of how social, economical, and environmental influences, (e.g., education, employment, and housing) can affect physical and mental health will be addressed along with a discussion of positive health outcomes of some successful interventions.

Conference Objectives

1. Participants will understand that all policy is health policy.
2. Participants will be able to explain the difference between “health equity,” “health disparity,” “health inequity,” and “social determinants of health.”
3. Participants will gain greater awareness of how policies impact the overall health of all Oklahomans.
4. Participants will identify new partners and kindle alliances to bolster efforts to positively impact health for all Oklahomans.
5. Participants will gain insight into a growing body of evidence demonstrating need for more “upstream” policies that provide all Oklahomans the opportunity for good health.

2012 Feature Speakers

RON SIMS

Ron Sims served for two years as the Deputy Secretary for the U.S. Department of Housing and Urban Development. Prior to his appointment at HUD, Sims served for 12 years as the elected Executive of Martin Luther King, Jr. County in Washington State, the 13th largest county in the nation with 1.8 million residents and 39 cities including the cities of Seattle, Bellevue and Redmond. As County Executive, Sims was nationally recognized for his work on the integration of environmental, social equity and public health policies that produced groundbreaking work in health care improvement, affordable housing, climate change, mass transit, environmental protection, land use, and equity and social justice.

RAJIV BHATIA, MD, MPH

Dr. Bhatia is the Director of Occupational and Environmental Health for the San Francisco Department of Public Health, where he has been responsible for developing and implementing environmental health law and policy in San Francisco since 1998. Dr. Bhatia has broadened the scope of local environmental health practice in the San Francisco Bay Area to include the issues of labor rights and working conditions, sustainable land use and transportation planning, traffic injury surveillance and prevention, and food policy. He co-founded the non-profit organization, Human Impact Partners, which works to advance the field of health impact assessment in the US. He has published numerous articles on HIA as well as other local health agency practices to achieve health equity. He is the co-editor of Tackling Health Inequities through Public Health Practice: Theory to Action.

MARY M. LEE, Esq.

As Deputy Director of Policylink, a national research and action institute advancing economic and social equity by Lifting Up What Works.® Mary Lee guides PolicyLink's Center for Health and Place, providing research, technical assistance, and training to public and private agencies collaborating to build healthy communities. She has co-authored reports and journal articles on access to healthy food, the built environment, and the impact of place and race on health. Lee is a practicing attorney with more than 25 years of experience working on civil rights, land use, and economic development strategies to revitalize neighborhoods and enhance public participation in the policy arena. Lee now serves as a member of the Los Angeles Food Policy Council. She is a graduate of Boalt Hall School of Law, U. C. Berkeley.

“Health Impact Assessment and the Healthy
Development Measurement Tool: Emerging
Strategies to Improve Public Policy”
Speaker: Rajiv Bhatia, MD, MPH

Economic, environmental and social conditions all determine the opportunities and obstacles for population-based health. Participants in this training workshop will learn about Health Impact Assessment (HIA). As a decision support, this tool assists in determining anticipated adverse and beneficial health effects for policy-related decisions. Learn how to apply HIA methods to land use, transportation, and employment policy. Public agencies as well the for-profit and non-profit sectors identify key applications for HIA and objectives and performance indicators for healthy development. Other tools that will be in review include the Healthy Development Measurement Tool (HDMT), which includes citywide healthy development objectives, measures to chart progress toward those objectives, development standards for project evaluation, and policy and design options, as a way to support productive engagement among

the health and planning sector. The use of HIA and the HDMT has resulted in significant improvements to the design of land use and transportation plans and projects and has facilitated collaboration between planning and health interests.
